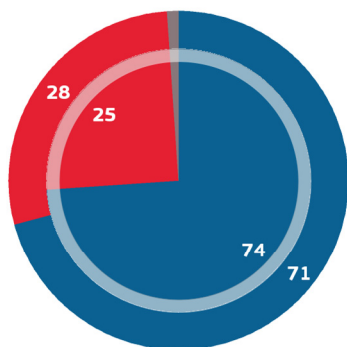

(%)



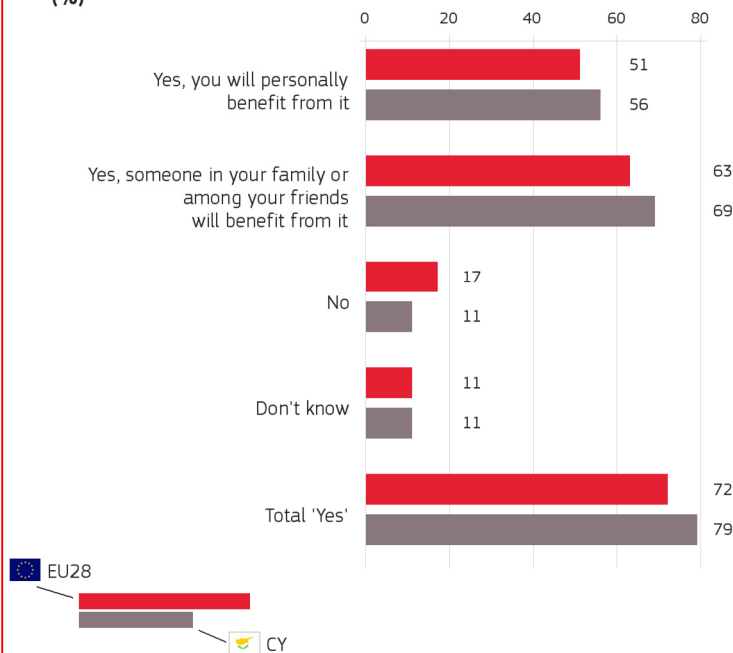

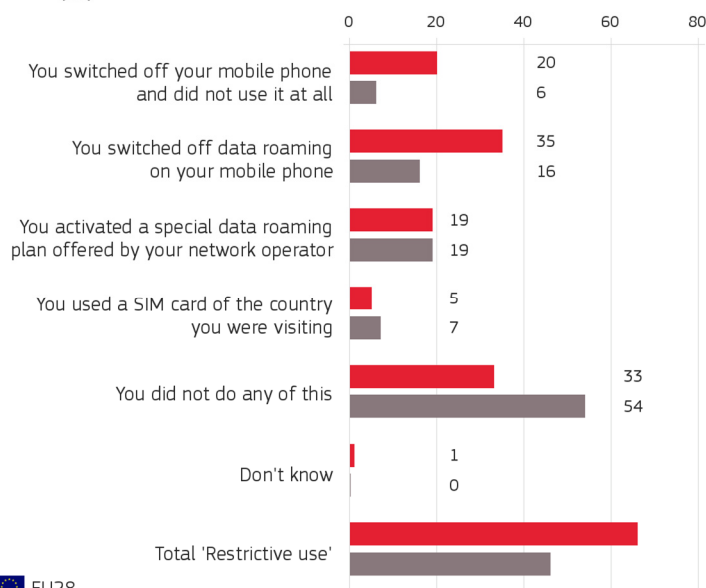

Q1R2 The last time you visited another European Union country, did you do any of the following? (MULTIPLE ANSWERS POSSIBLE)

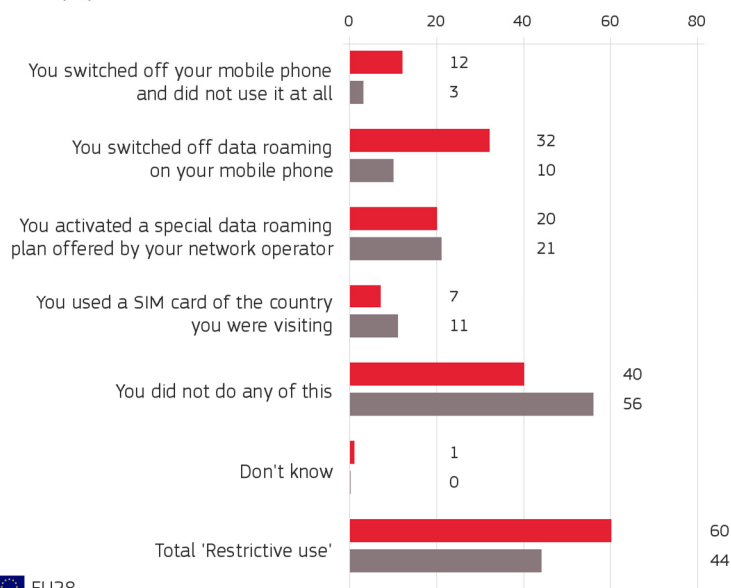

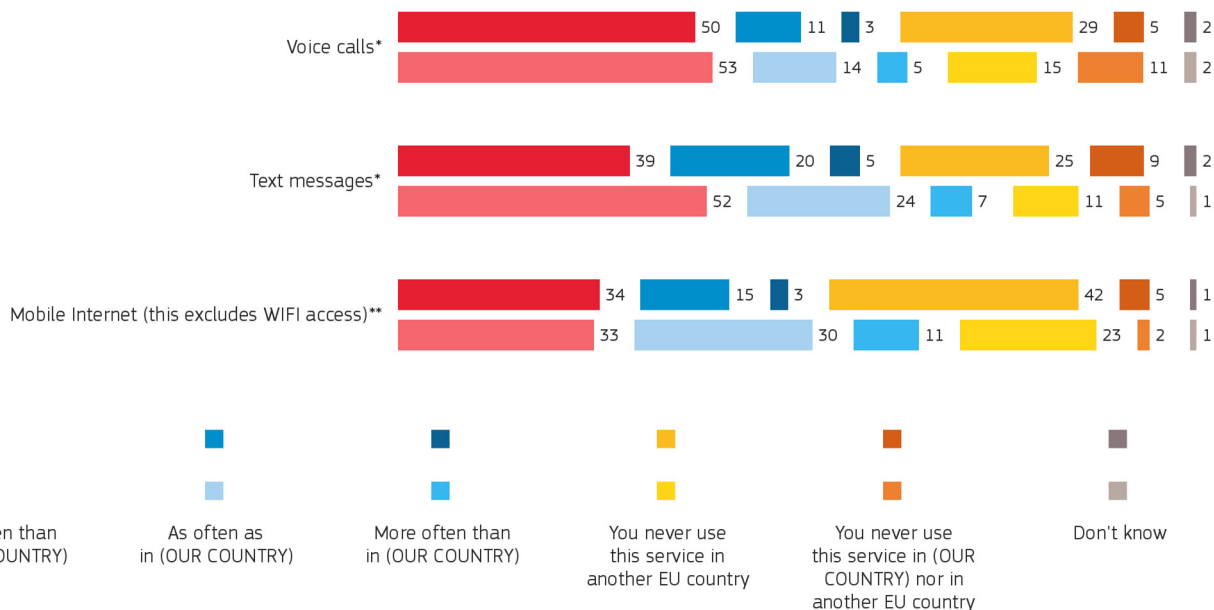

Q2AR2 The last time you visited another European Union country, how often did you use the following services on your mobile phone? (%)

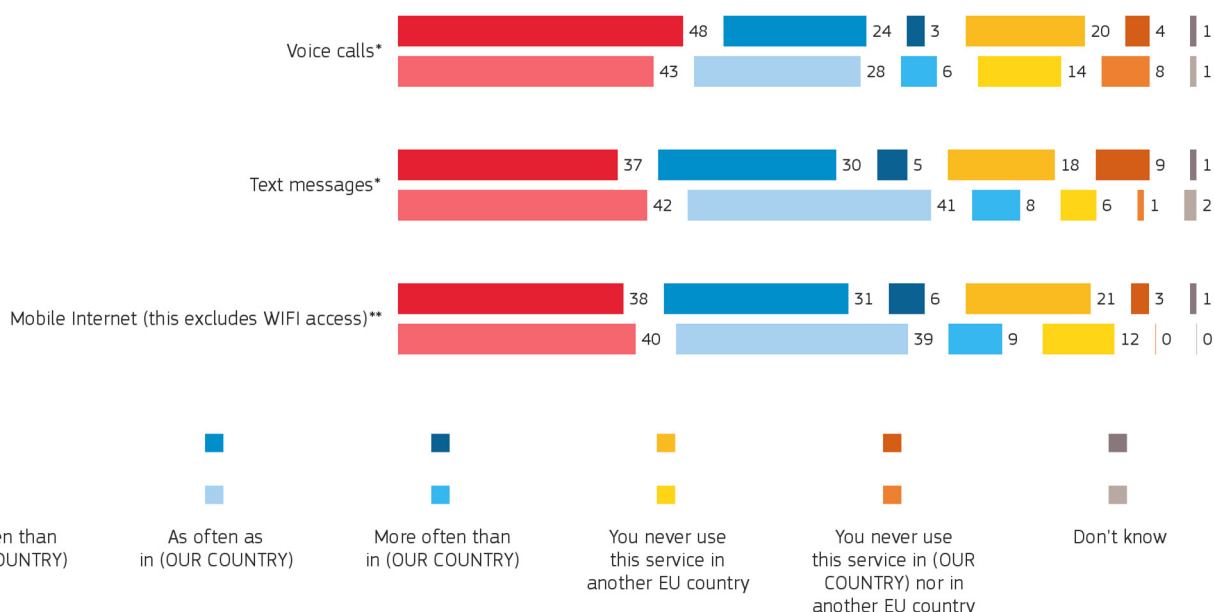
